SUMMARY

Eva Anduiza is full professor of Political Science and [ICREA Academia](#) research fellow. She founded the research group on [Democracy, Elections and Citizenship](#) in 2009, which she coordinated until 2023. She was 2018-19 fellow at the [Center for Advanced Study in the Behavioral Sciences](#) at Stanford University. She is the principal investigator of the Spanish Political Attitudes Panel, [POLAT](#), a long-term endeavor currently preparing its 15th wave (2010-2023). Her research has examined citizens' political engagement in advanced democracies. In recent years she has contributed to the understanding of how sexism and gender backlash are fundamental yet so far empirically neglected predictor of [far-right voting](#); how [polarization](#) changes along the electoral cycle, and hence can be enhanced (and reduced) by the proximity (distance) of elections; how populist attitudes are fostered by [anger](#) rather than fear, and facilitated by [internal political efficacy](#); how [populist attitudes](#) may work as a motivation for participation that compensates socioeconomic inequalities; how [new parties](#) can manage to quickly create party identities that are as meaningful and consequential as the identities with old parties; the different reasons for which people do not always punish [corruption](#) in elections; the negative consequences of violent tactics for [social movement support](#). Currently, she is working on gender backlash and on how individuals' attitudes toward gender equality and feminism change along time.
